AGREEMENT OF SERVICE

This agreement is entered into on the 13<sup>th</sup>(day) of February (Month) of 2019  
Between

M/s Ramky Energy And Environment Ltd., functioning at No,52/2 Chennakrishnapuram extension, Mayor Nagar, Salem - 07 and having its registered office at Ramky Grandiose- 13, Floor, Ramky Towers Complex, Gachibowli, Hyderabad – 500032 Telangana, (herein after called as REAEL) represented by its Mr.K.M.Nizar Ahamed, Assistant Manager, Authorized Signatory.

And  
M/s.Kasiyanna Gounder Hospital (A charity unit of vellalar educational trust),  
Pavalathampalayam,Perundurai Road,Erode.

1 Whereas REAEL has established a common treatment facility in accordance with Bio Medical Waste (Management and Handling) Rules, 2016, for Collection, transportation, treatment and disposal of the bio-medical wastes generated by the "Health care Establishments" (Hospitals, Nursing Homes, Diagnostic Centers, Dental Clinics, Blood Bank...

2. Whereas **M/s.Kasiyanna Gounder Hospital** is a hospital having **Thirty(30 Nos) Beds** are generating Bio – Medical Wastes which need to be managed in accordance With the Bio Medical Waste (Management and Handling ) Rules, 2016 of Govt. of India.
3. The **M/s.Kasiyanna Gounder Hospital** who uses the service of REAEL shall pay a onetime Membership fee of Rs1000/-towards membership
4. Whereas REAEL offers to provide the services required for the members of HCE to be Complied with the above said rules, on a "user-pay-principle" at **Rs.7.50 / bed / day** to be paid on monthly basis. IMA and Ramky Energy And Environment Ltd taking into an account the fluctuations in costs will review this rate every year.
5. **M/s.Kasiyanna Gounder Hospital** shall pay 45 days charges as advance to the REAEL.
6. REAEL & TNPCB will make periodic inspections of the **M/s.Kasiyanna Gounder Hospital** Regarding Number of Beds, Collection and Segregation of Bio – Medical Waste e.t.c.
7. The Health Care Establishments shall segregate the wastes in accordance with the Bio – Medical Waste (Management and Handling) Rules, 2016 of Govt. of India.
8. REAEL shall provide the initial training, free of cost, about segregation of wastes, Collection of wastes in colour coded bags as well as occupational safety in Management & Handling of Bio – Medical Wastes.
9. REAEL shall distribute colour coded bags (Bags – Rs.3.50/- per bag Extra-GST-18%), Puncture Proof Containers (Rs.250/- Per piece), Needle Destroyer Unit – Rs.2500/- (PPC & NDU" are one time purchase).
10. REAEL shall collect the wastes from **M/s.Kasiyanna Gounder Hospital** at times and frequency mutually agreed by both the parties. In case REAEL fails to collect the waste within 24 hours of previous collection **M/s.Kasiyanna Gounder Hospital** shall in form REAEL and the same shall be cleared within the next 24hours.
11. REAEL shall be liable for violation under the Bio – Medical Wastes (Management and Handling) Rules, 2016 from the time the waste is handed over to REAEL.
12. REAEL shall meet all the rules and regulations stipulated by the Tamil Nadu Pollution Control Board.
13. REAEL promises to keep high standards of pollution control and shall update equipments as and when required
14. All complaints (if any) shall be attended to in the shortest possible time, (48hrs).

15. REAEL shall send the bill for the preceding month by the 3<sup>rd</sup> of the next month and the Same shall be paid by DD or Cheque drawn in favour of Ramky Energy And Environment Limited payable at Salem.
16. The DD or Cheque should reach Salem Office on or before 15<sup>th</sup> of the same month.
17. Payments made after 15<sup>th</sup> shall attract penalty of Rs.30/- per day.
18. REAEL shall stop the services if payments are not made within 20 days from the date of billing.
19. Any change of Rules or Disputes will be sorted out by a joint committee of REAEL & HCE.
20. Agreement can be terminated by giving one month notice by both the parties.
21. REAEL & M/s.Kasiyanna Gounder Hospital hereby undertake to adhere to this "Agreement of Service" for the period of 12<sup>th</sup> February -2021.
