Resolutions

The following recommendations are suggested:

1. In Semester I, Core paper I "History of India upto AD 641" in Unit I, the topic Effects of geography on Indian History has been removed and geographical features has been included. In addition to the topic Later Vedic Civilizations, Early Vedic Civilization has been added.

In Unit II Instead of the topics Life and Teachings of Buddha and Mahavira and Political, Social, Economic Religious condition of India during the 6<sup>th</sup> cen B.C, the topics Buddhism and Jainism have been included.

In Unit III, The words 'Empire of' has been removed from Chandragupta Maurya and the new topic Satavahanas has been included.

In Unit IV, the words 'Rise and consolidation of the' has been removed from Gupta Empire and the topic Decline of the Guptas has been removed.

2. In Semester I, Core paper II, History of India from 647 AD to 1526 AD in Unit I, instead of the topics 'Invasions of Ghazni' and 'Conquests of Ghor', Muhammed Ghazni, Muhammed Ghor, Rajputs, Administration and Military System have been included.

The topics Chalukyas of Badami, Venkī and Kalyani, Rashtrakutas, Slave Dynasty have been included in Unit II. The topic the Lodis has been moved from Unit IV to Unit III. In Unit IV The topic Social and Economic life of the People has been removed. The topics Administration under the Delhi Sultanate and Bhakti Movement were moved from Unit V to Unit IV. In Unit V the Topics Rise and Fall of Bahmani Kingdom, Vijayanagar Empire, Krishna Deva Raya and Administration under the Vijayanagar Empire have been included instead of the topic Decline of the Sultanate.

3. In Semester II, Core paper III History of India from AD 1526 to AD 1707, in Unit III the topic Aurangzeb has been moved from Unit IV to Unit III. In Unit V Rise and Fall of Marathas and Rise of Sikhs have been newly included. Likewise, in Unit V, the topic Social and Economic condition under the Mughals has been included.

4. In Semester II, Core Paper IV History of India from AD 1707 - ND 1857, in Unit I Instead of the topic Carnatic Wars,

the topic Anglo-French rivalry has been included. Permanent settlement and subsidiary alliance has been added in Unit II and the topic Wellesley has been moved from Unit III to Unit II. The topic Social reform has been added in Unit III. In Unit IV The topic Military administration has been included and instead of Anglo-Sikhs relations, Anglo-Sikhs war has been included. The topic Dalhousie has been changed into Dalhousie Reform.

5. In Semester III, Core paper V History of India from AD -AD 1947, in Unit II the topics Indian Councils Act of 1861 and Growth of Nationalism has been removed. The word Formation has been removed from Indian National Congress, the word Birth has been included.
6. In Semester III, Core paper VI, History of Tamil Nadu upto AD 1336, The Topics Administration and Socio Economic Condition of the Sangam Age has been removed in Unit I. Nandhivarman, the no topic has been added and the topics Pallava's Administration, Social and Economic life and downfall of the Pallavas has been removed in Unit II. In Unit III, Social and Economic life has been removed. In Unit IV the topics Maravarman Sundara Pandiy II, Sadeya Varman Sundara Pandya I, Maxavarman Kulasekara Pandya I has been removed. The topic Art and Architecture and the Pandiyals has been moved from Unit V to Unit IV. In Unit V the topics Spread of Islam in Tamil Nadu has been included instead of Mal Kafur's Invasion. The topic Social and Economic condition of the Sultan has been removed and Sambavarayar has been added.
7. In Semester III SBS-Elements of Journalism, the topic Structure of News paper organisation has been added in Unit II. In Unit V, Free Press has been removed and News Agencies, Recent trends in Press has been newly added.

8. In Semester V, Core paper IX, History of Europe From AD 1453 - AD 1815, the topics Rise of Nationalism Monarchs and Charles V have been removed in Unit I. In Unit II the topic the Rise of Sweden has been removed and in Unit III the topic Rise of Prussia has been removed.
9. In Core Paper XII History of Japan from AD 1800 - AD 2000, instead of the topic Expansion in Asia and the Axis alliance, Manchurian Crisis and Second Sino Japanese War have been added in unit III
10. In Semester V Elective paper - I 'Archaeology' instead of the topic Scientific Dating, Dating Methods has been included in Unit I. In Unit II the topic Harappan culture has been moved from Unit III to Unit II, Important Archaeological Sites Kodumanal, Arikkamedu and Poompuhar has been included in Unit III. In Unit IV, the topic Coins of Cholas and Pandyas have been removed and the topic South Indian Coins and Temple architectural Styles have been included.
11. Instead of the Core paper XIV History of Semester VI, The Paper International Relations from AD 1919 to AD 1990 has been replaced with the New Paper India and her neighbours
12. The Board has approved the revised panel of Question Papers Setters and Examiners
13. The existing Syllabi of UGC approved career oriented Add-on Certificate, Diploma and Advanced Diploma Courses have been approved by the Board without any changes.

History course to be followed from 2018-2019  
onwards with above said changes.
