2. Vethathiri Maharishi Institute for Spiritual and Intuitional Education an educational wing of The World Community Service College (WCSC -VISION), Temple of Consciousness, Arutperunjothi Nagar, Aliyar, Pollachi, Erode Zone located at Erode Arivuthirukovil, 66 Periyar Nagar, 9th Street, Erode - 1 and Erode Manavalakalai Mandram Trust, Periyar Nagar, Arivu Thirukkovil, Erode - 1 herein after called the Second Party, represented by Erode Zone President / Zone Secretary do hereby agree the following:

3. Whereas WCSC - VISION contacted the College to conduct the Yoga for Youth Empowerment Courses and requested the College to offer space and infrastructure to commence the said courses and the College has agreed for the same subject in the following terms and conditions.

4. Application Form:

The application form and syllabus shall be prepared by WCSC-VISION. The Centre shall collect the required fee from the students and shall hand over the same to WCSC VISION, Aliyar.

5. Courses : Yoga for Youth Empowerment (YYE)

6. Course Materials:

The course materials shall be prepared by the WCSC - VISION. It is the responsibility of WCSC - VISION to provide necessary study materials for the benefit of students. The entire expenditure for the course materials, Practical, demonstrations, etc. and sharing of the same shall be discussed and agreed between College and WCSC-VISION, Aliyar.

7. Conduct of Classes:

The classes for the courses shall be conducted on Non-Semester pattern or Semester Pattern as required.

8. 8.1 The WCSC -VISION shall engage two yoga masters one for male and one for female for batch of 50 students with the qualification of Diploma in Yoga for Human excellence and preferably M.A (YHE).

8.2 The WCSC -VISION shall conduct the classes as per syllabus.

8.3 WCSC-VISION shall arrange additional faculties from its branch when admission increases.

8.4 Honorarium including transport charges shall be paid to visiting faculties by the WCSC - VISION.

8.5 WCSC VISION shall do everything to impart quality education ensuring values and excellence in actions.

9. Conduct of Examinations:

9.1 The Yoga Masters engaged shall closely monitor the programmes, make continuous internal assessment of students and take appropriate measures to ensure the quality of the agreed programmes.

9.2 Dates and schedule of Examinations for the Courses shall be intimated to the College by WCSC-VISION and will be announced by the College at the appropriate time.

9.3 The College shall conduct Examinations as per WCSC norms and valued by WCSC-VISION.

9.4 Certificates shall be issued by the WCSC-Vision Academy.

10. Joint Responsibilities:

10.1 If the students are not happy with the course content, WCSC-VISION shall take necessary changes required.

10.2 This MOU shall be valid for a period of three years from this date and can be renewed at an interval of three years on mutual consent. The collaboration is envisaged to provide admission for the academic year 2015-2016 onwards.

10.3 Any expansion or modification relating to the academic programmes shall be decided jointly by the College and WCSC-VISION.

10.4 All the terms and conditions of this MOU are subject to the approval of the various bodies of the College and the provisions of the Rules and Regulations of the College.

11. Termination:

College and any of the Governing Bodies of its associated institution feel that the operation of the Program will affect the integrity of the said institution then the College may terminate the arrangement with immediate effect. The College shall be entitled to terminate this arrangement by giving two months notice in writing to WCSC-VISION.




5. TERM OF THE CONTRACT







- Academic visits


Planning and handling of academic programs and courses, organization of seminars, workshops and conferences including the exchange of mutual experiences in teaching, research, and industrial practice.

REPORT

Two Faculty members and two lab assistants, attended the Faculty Development Programme on "VALUE ADDITION OF BANANA", organized by the Department of Food Processing Business Incubation Centre, Indian Institute of Food Processing Technology, Ministry of Food Processing Industries, Govt. of India, Thanjavur. Dr. Vincent Hema, Assistant Professor, Dept of Food Science and Nutrition of this institute was the resource person.

In the Introductory session, the intension on value addition to enhance the value of the product from its original state in terms of physical state or the form of the product were intended. The explanations were given on the vital role of banana in maintaining normal blood pressure, healthy digestion and eases out constipation and therefore banana was selected for the value addition. The use of Osmo-solar dehydration technology in the development of Value addition of banana was explained. The three key elements for successful industrial marketing were discussed i.e., Taste, Texture and Therapeutic uses. Banana, a highly perishable fruit, owing to its high moisture and climacteric nature, hence value addition processing techniques viz, Solar assisted drying, sun drying, tunnel drying and radio frequency sterilizing were elucidated in maintaining the shelf life stability for about 3- 6 months.

In the afternoon session, ingredients and procedure for the preparation of the product using banana were demonstrated. As a first step, the ripened banana was subjected to processing by drying under osmo-solar dehydration. Since Osmotic dehydration technique is time consuming, the method of Osmo-solar dehydration (Osmosis – dipping in sugar syrup) is adopted for drying. Finally the packing technologies were explained for maintaining the product stability. The huge potential of value added banana products will boost the economy of the country.



CONTRACT AGREEMENT

1. PARTIES ENTERING INTO THE AGREEMENT

This Agreement is entered into, on 24/6/2014 by and between the following two Parties:

a. **Informatics Publishing Limited**, incorporated under the Companies Act 1956, having its registered office at #194, R V Road, PB No 400, Basavanagudi, Bangalore-560004, Karnataka, hereinafter referred as "IPL", which includes its heirs, successors, and assigns represented by Mr. N.V.Sathyararyana, Chairman and Managing Director.

AND

b. **Vellalar College for Women**, having its registered office at Vellalar College for Women (Autonomous), Thindal (P.O.), Erode - 638012 hereinafter referred as PUBLISHER, which includes its heirs, successors and assigns represented by Dr. D. Kamalaveni, Principal.

2. OBJECTIVE OF THE AGREEMENT

The objective of this Agreement is to define a working relationship between the parties for online hosting, pre-publishing services as well as promotional activities through i-Scholar for **journals published by Vellalar College for Women**, hereinafter referred to as **Journals**.

3. BACKGROUND OF PARTIES TO THE AGREEMENT

- 3.1 Informatics Publishing Limited (IPL) is engaged in the business of e-publishing, marketing and distribution of information products and services, providing editorial and content management services to Publishers and Institutions. IPL provides a wide range of e-publishing services to scholarly journal publishers for online management of end-to-end publishing process from manuscript submission by authors to peer-reviewing, editing, electronic photo-type setting, publishing, subscription management and hosting the content for online searching and delivery to subscribers. For this purpose IPL has a technology platform that supports and automates the publishing process.
- 3.2 PUBLISHER is engaged in the business of publishing journals, newsletters and other documents. The PUBLISHER desires IPL to publish the online and print versions of their journals and use certain services like i-Scholar, J-Gate and other content aggregation products offered by IPL under this Agreement.

3.3 Through this Agreement the PUBLISHER appoints IPL as its e-publishing service provider and both parties agree to perform as per the terms of this agreement.

4 DEFINITIONS

For the purpose of this Agreement, the words and phrases listed below carry the specific meaning expressed herein.

- 4.1 **Journal** refers to the published print or electronic version of the Journals listed in Annexure A.
- 4.2 **E-publishing** refers to electronic reproduction and reformatting, online hosting delivery and management of the content provided by the PUBLISHER or their authorized associates such as Authors, Editors, Peer-reviewers etc., for publishing as papers in any of the journal as assigned by the PUBLISHER.
- 4.3 **Volume** refers to a set of issues published under a designated series of numbers in numerical or alpha-numerical order.
- 4.4 **Issue** refers to the published copy of a journal covering a designated publication period and numbered numerically or alpha-numerically as part of a Volume.
- 4.5 **Promotional Activities** refers to the sales and marketing activities performed by IPL for the Journal in order to increase the readership of the journal.
- 4.6 **Archives** refers to the back volume of the journal articles available as bundle to a subscriber either at cost (for non-subscribers) or bundled with current subscription cost (for subscribers) having coverage from the 1st digital volume available on this platform till the last digital volume available along with current subscription of the journal.
- 4.7 **Licensing** refers to licensing of the Content of the journals listed in Annexure A by the PUBLISHER to IPL for the purpose of e-Publishing, storing in e-version, marketing and distribution and archiving permanently one copy of every article/journal as safe back-up on behalf of the PUBLISHER and under PUBLISHER'S copyright.
- 4.8 **Database** means structured cumulative content of the published electronic version of the Journal developed and regularly updated by IPL from time to time as a searchable content using a search engine.
- 4.9 **OJMS** refers to an online technology platform for publishing and managing the editorial and publishing process of Journals used by IPL under license from Informatics India Ltd., the parent company of IPL.
- 4.10 **i-Scholar** refers to proprietary online search system developed by Informatics India Ltd., the parent company of IPL for hosting e-Journals and making them available for online searching through a secured access management system.
- 4.11 **Revenue** refers to net proceeds by IPL, net of taxes and distributor's commission, from the sale of the Journal content, in its print or e-version, as annual subscription or back files or single article under various business models developed by IPL from time to time.
- 4.12 **Perpetual Access Rights** refers to the permanent access rights to the customer on purchase of/subscribing to the e-version of the journal.
- 4.13 **Limited Period Access or non-perpetual access** refers to annual lease model of access. The customer will be provided access to the subscribed portion of the e-version of the journal by year or volume during the year of subscription only. The customer will not have permanent access or retention right after the expiry of the subscription.
- 4.14 **Pay per view or article purchase** refers to purchase of selected articles by the customer.

5. GRANT OF RIGHTS

- 5.1 Under this Agreement, the PUBLISHER grants to IPL exclusive world-wide rights for e-publishing, hosting, aggregation, marketing and distribution rights for the Journal listed in Annexure A. Roles and responsibilities of IPL and PUBLISHER are set forth in Sections 7 and 8 of this Agreement.
- 5.2 Copyright: The copyright for the content is owned by the PUBLISHER with e-publishing rights assigned to IPL under this Agreement. Following are the services that will be provided by IPL to PUBLISHER during the validity of this agreement

- 6.1 i-Scholar (Online marketing and print distribution)
- 6.2 Marketing and promotional activities for the journal—in print, online and print + online formats under revenue share model
- 6.3 IPL will assist in procuring DOI for the articles at PUBLISHER'S cost
- 6.4 IPL will assist in plagiarism check for articles at PUBLISHER'S cost
- 6.5 IPL will assist in procuring print ISSN and eISSN for the journals
- 6.6 IPL will manage the print runs for the journals at PUBLISHER'S cost

7. RESPONSIBILITIES OF IPL

- 7.1 IPL will host the journal on i-Scholar.
- 7.2 IPL shall undertake all activities with respect to digitization of back files of the journal and upload the PDFs of articles from Volume 1 to the present volume on the journal website at PUBLISHERS cost (if any).

- 7.6 IPL shall establish the rules for submission of content for the Journal, and procedures for review of content prior to its submission for publication in discussion with the Publisher.
- 7.7 IPL will manage the print runs of the journal with print distribution at PUBLISHERS cost.
- 7.8 IPL will, to the extent possible, keep the database updated with the latest information available from PUBLISHER. IPL will not be responsible for accuracy of the information as provided by PUBLISHER.
- 7.9 IPL will share regularly with the PUBLISHER information relating to client's, their subscription and revenue from the sale of PUBLISHER's content on a quarterly basis.

- 7.10.1 Perpetual access for the journal subscribed for a given period; under this model the subscriber will have permanent access rights as defined in Section 4.12
- 7.10.2 Limited period access for one year for the journal subscribed on annual lease model as defined in Section 4.13
- 7.10.3 Pay-per-view which refers to purchase of specific articles
- 7.11 IPL will exclusively manage the distribution activities of the print journal and will share the subscriber and revenue details with the PUBLISHER on a quarterly basis. Printing of the journal will be managed by the PUBLISHER.
- 7.12 IPL will apply for DOI number for the articles at PUBLISHER's cost.

- 7.14 IPL shall email the up-to-date list of all subscribers with postal addresses and email addresses to the PUBLISHER
- 7.15 IPL will determine the pricing for marketing and distribution of the journal through its services such as i-Scholar, J-Gate, etc as per its policy.

8. RESPONSIBILITIES OF PUBLISHER

- 8.1 PUBLISHER shall provide all back issues of the Journal either in print form for digitization or in e-version as available with them for the purpose of archiving.
- 8.2 PUBLISHER shall allow IPL to provide free trial access for a period of one year to the customers for marketing and promotional purpose.
- 8.3 The selection of papers for publication in journal and publishing rights of the journal will remain exclusively with PUBLISHER.
- 8.4 PUBLISHER shall obtain author copyrights and permissions for articles.
- 8.5 PUBLISHER shall manage the editorial process involving manuscript submission, peer-reviewing, content editing.
- 8.6 Publisher shall provide IPL final edited manuscripts for typesetting of the Journal and create final output files in web-ready and print-ready formats for printing activity. While performing these activities IPL will adhere to the style guidelines and other procedures adopted by PUBLISHER.


9. ACCESS THROUGH I-SCHOLAR, J-GATE AND OTHER CONTENT AGGREGATION PRODUCTS OF IPL

- 9.1 IPL will aggregate and market PUBLISHER's Journal through its i-Scholar, J-Gate and other content aggregation products. All users will have free-access to the aggregated journal content up to abstract level only with an option to: buy an article, or subscribe to a selected list of journals, or subscribe to a collection of journals in pre-defined categories.

10. FEES, PRICING AND REVENUE SHARE

- 10.3 For only online subscriptions: Revenue share will be PUBLISHER: IPL = 50:50 of net revenue generated (gross revenue less distributor margin / commission and service tax and any other taxes collected)
- 10.4 PUBLISHER will pay IPL towards procuring DOI for each article at the cost of Rs. 150.
- 10.5 PUBLISHER will pay cost of Rs. 150 towards plagiarism check for each article. (CrossCheck powered by i-thenticate)
- 10.6 IPL will assist in pre-publishing activities (copyediting & typesetting) at PUBLISHERS cost.
- 10.7 IPL will manage the print runs for the journals at PUBLISHER's cost.
- 10.8 Revenue share will begin for subscriptions and usage beginning June 2015.
- 10.9 Royalty becomes payable after IPL has realized the payments from the customers and will be paid quarterly. All royalties are subject to tax deducted at source.
- 10.10 Online and Online + Print subscriptions of the journal currently attract service tax 12.36% for India and Foreign.
- 10.11 All royalties will be subject to tax deducted at source.
- 10.12 IPL will send the sales statement net of distributor's commission to enable PUBLISHER to raise invoice. The invoice should be sent to IPL address within 7 days of every month for the purpose of accounting and payment. However, the payment to the publisher will be made as per the agreement.

11. TERM AND TERMINATION

- 11.1 The initial term of this agreement shall be for five years from the effective date of agreement and will automatically renew each year for successive periods unless either party decides to terminate after the initial term.
- 11.2 After the initial period, each party may terminate this agreement (effective the following year/volume of termination) at any time during the term of this Agreement upon giving 180 (One Hundred Eighty) days prior written notice to the other party.
- 11.3 In case of insolvency, bankruptcy or liquidation of any party, the other party may terminate this Agreement by giving 30 (thirty) days written notice.
- 11.4 In case of breach of any terms and conditions by either party, the other party may terminate this agreement by giving 30 (thirty) days prior written notice, if the breaching party fails to remedy the alleged breach within 30 (thirty) days from the date the affected party notifies the breaching party of the problem.
- 11.5 Post termination rights and responsibilities:
- 11.5.1 In the event of termination of this agreement by either party, all documents furnished by one party to the other in connection with the relationship shall be promptly returned by the receiving party.
- 11.5.2 Following the termination, IPL shall retain the non-exclusive rights to license or sell only the electronic archives of the journals for satisfying the access needs of the customers to whom perpetual rights of access is granted. The revenue generated from the sale of archives will continued to be shared with the PUBLISHER post termination.
- 11.5.3 IPL agrees to service all orders registered as on the date of receipt of notice until the expiry of those orders.
- 11.5.4 IPL agrees not to receive any new orders or renewals after the date of termination and further agrees to transfer all orders received to the PUBLISHER after the date of termination.

14. RELATIONSHIP OF THE PARTIES

14.1 This Agreement shall not be regarded as creating a joint venture, partnership or other form of association between the parties. Neither party shall have any right to enter into any agreement/undertaking directly/indirectly which binds the other Party otherwise.

15. COVENANTS

15.1 Both the parties hereby jointly covenant that both of them shall employ their reasonable endeavors and co operate with each other to discharge their respective obligations under this agreement.

15.2 Within the validity of this agreement each Party shall not discuss or enter into any relationship with any other third party except otherwise stated in this Agreement without the written consent of the other party.

16. FORCE MAJEURE

16.1 If any event of force majeure continues for a period in excess of ninety (90) consecutive days, resulting in the inability of a party to perform its business activities under the terms of this agreement, either party shall be entitled to terminate this Agreement upon written notice. In this case there will be no liability on either party.

16.2 The term force majeure used above shall mean acts of God, acts of any public enemy, wars, hartals, blockades, insurrections, riots, epidemics, landslides, lightening, earthquake, fires, storms, floods, civil disturbances, terrorisms and any other cause not within the control of the affected party; all of which by the exercise of due diligence such party is unable to prevent.



17.2 Any notice sent by facsimile or other electronic means shall be deemed to have been duly served at the time of transmission.
