On behalf of the Antiragging Committee the "Orientation Day" for the fresher's was held on 05.07.2020 to create awareness on the regulations adopted in the campus to curb ragging.

As per the directions of UGC/MHRD, the 1st year students were made to fill the online undertaking forms of antiragging and the hard copy was collected from the parents and students.

Anti ragging committee and District Legal Services Authority, Erode jointly organized a legal awareness programme on 17.10.2020. **Tmt. S. Lakshmi, Secretary/Sub judge, District Legal Services Authority, Erode** delivered a special lecture on "Women's rights" in the programme. The speaker highlighted about the rights of victims of ragging and the duties of Educational Institutions on ragging and also stressed that it was a nonbailable offence.

Tmt. B. S. Kalaivani, Judicial Magistrate No-1, Erode and Thiru. G. Sivakumar, I Additional District Munsif, Erode gave awareness about the ills of ragging amongst the students. The speakers directed that there is a National Anti-Ragging Helpline to help the victims and take action in cases of ragging, by informing the head of the institution and the local police authorities of the ragging complaint from the college. The main feature of the helpline is that the complaints can be registered anonymously.

The committee guides the students by placing bill boards and hoardings on details of anti ragging committee members and their contact numbers.

Ragging Curb Committee has been constituted for the academic year 2018-19 with faculty and student members to curb ragging in the campus.


An **Orientation Programme** for the 1 year UG students was organized in the beginning of the academic year to create awareness about the regulations followed in the campus to curb ragging.

- With reference to the letter received from the Directorate of Collegiate Education dated 18.06.2016, the Principal convened a meeting on the following matters and she insisted to implement them immediately in the college premises.

 - ii. To fix complaint/suggestion boxes in the college premises.
- On 22.06.2015 student members of Ragging curb committee were selected for the academic year 2015-16.
- Posters on Anti ragging was received from Secretary, University Grants commission, New Delhi and was displayed at prominent places of the institution.
- Three member committee consisting of Psychiatrists/Psychologists to counsel the students were allocated for each district by the Governor of Tamil Nadu. With reference to their communication, we displayed the list of these committee members of Erode districts in the college premises.
