Resolutions.

The following recommendations are suggested.

In Semester I, The Core paper - I History of Delhi Sultanate from AD 1206 to AD 1526 has been replaced with the Paper History of Ancient India and the Paper History of the Mughals from AD 1526 to AD 1773 has been replaced with the Paper History of Medieval India as Core paper II

In Semester II, Core paper III Constitutional History of India from AD 1773 to AD 1950. In unit IV, Cripps Proposal, Wavell Plan and Cabinet Mission Plan have been removed and the topics Salient Features and Preamble have been included. Instead of the topics,

Lok Sabha, Supreme Court and 42nd, 72nd and 73rd amendments to the Constitution, the new topics Parliament and Judiciary have been included in Unit - V.

In Semester I, Core Paper IV 'History of Indian National Movement since AD 1885', instead of the topic Role of revolutionaries, only revolutionaries has been retained in Unit - II. In Unit - III, the new topic Poona Pact has been included.

In Unit IV - the topic Role of Press in Indian Freedom Movement has been removed.

In Semester III, Core Paper IX History of Ancient Civilizations upto AD 476 (Excluding India) has been replaced with the new Paper 'History of Civilizations'. Instead of the Paper X, History of Medieval Civilizations from AD 476 to AD 1453, a new Paper on 'Contemporary India' has been introduced. The Paper 'History of Modern Civilization from AD 1453 to AD 1970, has been replaced with the Paper 'Human Rights' as Core Paper XI.

In Core Paper XII 'Historiography and Historical Methods', the topics in Unit V have been completely removed and the topics in Unit IV from Objectivity in Historical Writing, Foot Notes, Bibliography and Documentation have been moved to Unit V.

In Elective Paper - III 'Archives Keeping', in Unit - V, the new Paper on 'International Relations from AD 1945 to AD 2000' has been introduced.

The Board has approved the revised Panel of Question Paper setters and Examiners.

It is resolved to Pass the Syllabi of MA History Course to be followed from 2018-2019 onwards with above said changes.
