	<p>The Chairpersons of the respective Boards of Studies highlighted the choices under the CBCS pattern and proposed the revisions and modifications in the syllabi which had already been passed in the respective Boards of Studies held on 19.07.2008 and 21.07.2008 and in the Standing Committee held on 23.07.2008, for the approval of the Academic Council. 

	The Principal indicated that the syllabus for 'General Awareness' should be prepared incorporating the current trends and the same be completed by the end of the academic year 2008-'09.	
	The question paper pattern was discussed in detail and the University nominee, Dr. S. Govindarajan suggested that a uniform question paper pattern be followed for papers offered under Part-III of all disciplines as detailed below:	
	Section - A - 10 Questions	of 1 Mark each with no choice.
	Section - B - with restricted	choice (either or Pattern)
	Section - C - with open	choice.
	Regarding the number of questions and distribution of marks for Section B and C in Part III and Sections A, B and C in Part I and II it was decided to implement the decision of the respective Boards of Studies. The Grading pattern was also discussed and Dr. S. Govindarajan stressed upon the need to formulate a grading pattern with no anomalies with respect to the students' Cumulative Grading Point Average (CGPA) and the percentage score.	
	Dr. D. Mangalraj, the University nominee was of the opinion that in case of anomalies in	grading, the Head of the Institution, shall


be the authority to rectify them keeping in view the best interest of the student community. He also suggested the introduction of inter-disciplinary choice based courses and supportive courses from the academic year 2009-10.

The queries of the Chairpersons of various Boards of Studies regarding Degree with compulsory Diploma and credits for MCA course have been clarified by Dr. D. Mangalraj, Dr. S. Govindarajan and Dr. V. Dhazalan and their views were endorsed by Dr. M. L. Sengodan, the Management nominee. The need to introduce a Certificate course in 'Yoga' of 180 hours duration has also been discussed.

Thiru. C. Jayakumar, the Management Nominee suggested that revisions and modifications as per the CBCS pattern should suit the student needs. Prof. Mrs. Chandia Thargavel, Dean and Management Nominee to the Academic Council expressed similar views.

The CBCS pattern regulations and the revisions proposed by the Principal and the Chairpersons of the Boards of Studies were summed up by Dr. V. K. Shobhana, Member Secretary and they were duly approved and passed by the Academic Council for implementation with effect from the academic year 2008-09.
