Welcome Address and Principal's briefing on the Academic achievements for the year 2016-17. and the results of End Semester Examination - NOV 2016.

## Resolution i:

Dr. D. Kamalaveni, Principal welcomed the members present at the meeting of the Governing body. She also presented a brief report of academic achievements and other activities for the year 2016-17.

A grant of Rs. 22,93,591/- was received from the UGC during the academic year 2016-17. The UGC-CPE has accepted the proposal for the continuation of CPE Scheme during XII Plan period and Sanctioned an amount of RS 1.25 crore for a period of five years from 2017-18.

A grant of Rs. 80 Lakhs was sanctioned by Department of Science and Technology under FIST programme, out of which Rs 69.50 Lakhs was received and spent in 2016-17

Department of Bio-Technology (DBT), Ministry of Science and Technology of Government of India under STAR College Scheme had sanctioned Rs 58 Lakhs for 3 years, out of this Rs 36 Lakhs

Mathematics (UG) had revised the syllabi of Allied Mathematics for B.Sc Physics and B.Sc Chemistry and Allied Mathematics and Statistics for B.Com.

Revision of Allied Physics Paper I and II are carried out by Physics (UG) and Allied Chemistry papers I & II are done by Chemistry.

The boards of Mathematics (UG), Physics (UG), Chemistry, M.Sc Computer Science, M.Lib.I.Sc have revised some of their Elective papers.

Few of the Skill Based Subjects are revised by Botany (UG), Zoology, M.Sc Computer Science, F+N and BBA (CA).

The Boards of Chemistry, Zoology, Bio Chemistry, F+N, Costume Design and Fashion had revised their Non major Elective papers.
